Electronics Service & Training Centre (ESTC) has been established as a Govt. of India Society, registered in April, 1986, under the Societies Registration Act. 1860. The main objective of setting up this project is to develop human resources to meet the essential requirements for transfer of technology in assembly and manufacturing of electronics items and parts.

Principal Director, being the Executive Head of ESTC, shall be responsible for day-to-day management and affairs of the Society and shall exercise his powers under the direction, superintendence and control of the Chairman of the Governing Council.

Applications are invited from citizens of India for the post of Principal Director in Electronics Service & Training Centre, Ramnagar which is proposed to be filled up on contract basis for a period of 5 years initially with further extension based on the review of performance of the individual. a. Essential: 15 years experience in Electronics Engineering Industries/Reputed Industrial

Development Organisation in Production/Training/Design Dept./Calibration and Testing department/ Quality Management Dept., etc. out of which 10 years should be in

a responsible Technical/ Management position.

b. Desirable: Development of Industries/Projects/Quality Management Systems; Implementation &

Management of Engineering Projects; Use of computerized MIS; NABL Accreditation, procedures & Laboratory Management; ISO 9001/14001 systems; Administration,

Finance and Labour Management.

c. Scale of Pay: PB-4, Pay Band- Rs.37,400 to 67,000/- and Grade Pay- Rs.8,900/- . The post besides

basic pay (pay in pay band + grade pay) carries allowances as per government rules.

d. Age: 50 years (relaxable up to 5 years for SC/ST/Internal candidates and 3 years for OBC
